We had a quiet little program before the gifts were given out and I made a little speech of welcome and told "the why" of a Sunday School.

There were forty children there and about the same number of adults, members of the school, and about sixty others some coming six or seven miles and all but twelve came over three miles and through woods.

We are quite proud of how the little folks attended as there were only five within a radius of three miles and we average twenty-five.

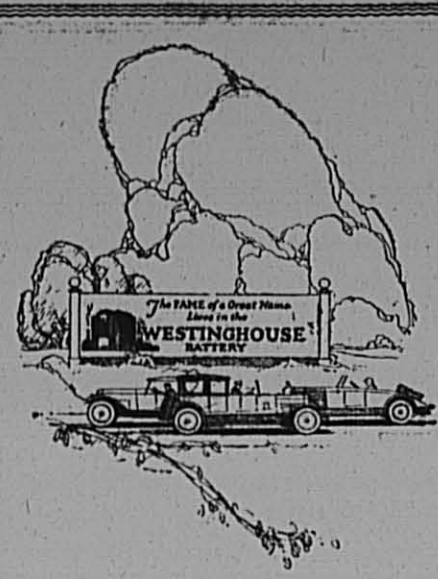
