Groves Mansion status still undecided

Ahead of a 6/24 Planning Board session, the HSR urges preservation of the historic home

The 1901 home of a steamboat company president has another date with the Planning Board, on August 24, 2021 at 7:00 pm.

We mentioned in the May 2021 issue and in our April web post, "A unique Riverton restoration opportunity!" that the Edwardian home of steamboat company president Frederick S. Groves is in need of some-

one with restoration experience who is unafraid of a big (but beautiful) job.

So here is an update. Background: the property is 409-413 Lippincott Ave., right in the middle of the Riverton Historic District, on one of our most beautiful streets. It is listed as a "contributing resource" to our district that is

on the National Register of Historic Places.

It is a big house on a full acre lot, built in 1901 to a design by Philadelphia architect **Frank Mercer** as a total rebuild of an earlier, smaller house. To build it, the owners assembled three smaller lots in order to have room for this expansive home.

In recent years, its latest owners (now deceased) allowed it to deteriorate, though they did some good work on parts of it.

Their estate put it up for sale in January. JRB Properties purchased it on March 26 at a premium over asking price. (JRB Properties is an LLC of new-home builder Jim Brandenburger,

Roger Prichard is now the Borough Historian

At the May 18, 2021 meeting of the Riverton Borough Council, Mayor Suzanne Cairns Wells announced the retirement of Borough Historian Paul Schopp and the appointment of Roger Prichard as his replacement.

With a superb grasp of Riverton's history as well as having insight into how our town fits into the larger scheme of the region, Paul Schopp provided distinguished service for eight years as our second Borough Historian. **Betty B. Hahle** was the first.

Mayor Cairns Wells and Borough Council
issued a joint proclamation declaring Paul
Schopp to have "earned the respect and admiration of the residents of Riverton through his
extensive contributions."

Mayor Cairns Wells told Council, "When I learned that Paul wanted to resign, I immediately knew that Roger was the obvious choice

to succeed him."

We are grateful that Paul will continue to consult for us as his schedule allows.

Roger Prichard is an HSR Board member who may be best known to Rivertonians as the creator of most of HSR's growing collection of his-

torical markers along the riverbank, at the Riverton Free Library and at Riverton School.

Roger looks forward to this new appointment, with the opportunity to speak for the interests of Riverton's history and its historic places, as they have no voice of their own.

"preservation"has been our mission since our inception

Founder Mrs. Betty Lockhart wrote a letter to a local newspaper, inviting anyone interested in forming a historical society to meet at her home to discuss it. On June 4th, 1970, 54 persons attended the first meeting held at the Porch Club and voted to form such an organization.

They decided to meet twice a year and elected Mrs. Lockhart as its first president. By 1974, the organization had drafted a constitution and bylaws and became incorporated. Mrs. Marilyn Colozzi wrote a one-page undated newsletter containing announcements of activities which the group christened the Gaslight News, named for the quaint streetlamps which, at that point, PSE&G had earmarked for removal.

That modest beginning was the start of the Historical Society of Riverton.

Due largely to the activism of HSR members, those original 52 gaslamps were saved in the late 1970s, thus preserving the Victorian atmosphere of the town.

Later years saw many more preservation achievements:

- Conversion of Romance of Riverton film to video
- Microfilmed then later digitalized historic hometown newspapers
- Conservation of maps, photos, and documents
- Initiated historic house plagues
- Nomination of Riverton's Historic District to the NJ and National Registers of Historic Places
- Introduced website & Facebook
- Installation of historic markers
- Organization and storage of irreplaceable HSR collections

who has constructed a number of houses in Riverton over the years, none involving historic properties.)

The new owner immediately proposed cutting the 225' frontage it into three pieces. JRB promptly relisted for sale the center third (only the part holding the historic house) on the assumption that they would be able to get the Riverton Planning Board's approval for subdivision to create two more lots, on which they would build new houses.

No parts of that subdivision proposal are permitted by legal right under the zoning code

(nor is a demolition permitted for the purposes of subdivision, if it comes to that). The proposal would result in very narrow side yards for the historic home (which for 120 years has had

side yards of about 80', as designed). One of the other lot frontages would also be narrower than legally permitted.

IRB has also marked with spray paint all of the mature trees to be removed. An informal count and measurement of those over 10" in diameter showed that twenty trees would be destroyed, including a gingko 30" in diameter, a double holly 37" and a beautiful copper beech.

Throughout, the Historical Society of Riverton (HSR) has had an active email list to keep

its board and interested neighbors informed.

In June, the HSR wrote a letter to the Planning Board for the first hearing urging that every effort be made to protect it.



Borough Historian Roger Prichard also made a detailed six-page statement, putting it in the context of Riverton's



strong tradition of historic preservation and its Master Plan, which encourages it.

The Borough's Architectural Review Committee then met with JRB and subsequently wrote a letter to the Planning Board with an unambiguous statement, affirming, "The mansion was designed to occupy the entire



two hundred twenty-five (225) foot frontage. Changes to that are a loss to the mansion, the historic fabric of the Borough and the neighborhood."

All three of those statements placed preservation of the entire one acre parcel as their strongest recommendation.

JRB requested a postponement from the Planning Board until its August meeting. No reason has been released for this and it is not known how they might intend modifying their proposal. Mr. Brandenburger has said that he has a qualified buyer for the historic house itself on the center third of the property, who is prepared to restore it. HSR is concerned that this further delay could be harmful, as it seems that maintenance of the property has come to a standstill.

Though JRB has cut the grass sporadically, the one acre yard has become overgrown with shrubbery and vines climbing the historic house, raising worries by neighbors and many others that it is on the road to "demolition by neglect."

Criterium grant funds HSR huge preservation task

Archives Preservation Committee Chair Keith Betten and members Iris Gaughan and Pat Brunker with processing volunteer Pat Solin tackled the massive task of organizing and cataloging the HSR Collection



A \$4,000 grant in 2016 from Carlos Rogers' Historic Riverton Criterium underwrote our still ongoing historical marker project; another \$5,500 HRC grant in June 2019 established a fund to organize our growing historical collection.

The HSR Archives Committee reports that more than twenty-five percent and perhaps nearly thirty-three percent of the society's current archival documentary holdings have been fully catalogued, described and housed in permanent, labeled boxes on the shelves of the storage racks in the archives storage section in the basement of the Riverton Free Library. Finding aids for all of these records have been prepared and will soon be available for access on line.

Included in the completed Record Groups/Subgroups are all archival records of the Borough of Riverton, the Riverton Porch Club, Public School Records (including Riverton Public School, the PTA/PTO, and Palmyra High School), and the Riverton Free Library (including documents

from its 1899 founding - An-

nual Reports, Treasurer's Reports, Accession Records, Circulation Records, Members Records, and Accounting Records, etc). Also, soon to be processed are the recently discovered "first" and "second" Minute Books of the Riverton Improvement Company which describe the official activities of Riverton's founders between RYC Minute Book PHOTO: JMC 1851 and 1864.

Calling from his Florida residence, Steve Loving inquired about his parents' former homestead at 307 Bank Avenue (now demolished to make room for Baptist Home expansion) because he planned to visit Riverton.

HUNN SAILS TO WIN IN RIVERTON EVENT

Riverton, Aug. 21.—Taking the lead with a 100 feet to go, Knute Hunn won top honors yesterday in the dusters division, sponsored by the Riverton Yacht Club. Nine competed in the event on the Delaware River.

Second place went to Lou Cleiland, followed in the order named by John Malloy, Mrs. Woodward, Miss Michener, George Kimball, Miss Michener, George Kimball Les Kimbal and Charles McCann.

The Yacht Club awarded his mother Geraldine Michener the Upside-Down **Trophy** for being "...the member who performed the most spectacular dumb stunt or the most dumb stunts during the year" in 1944 but misspelled her name Gerry as Jerry.

What she did to earn that hapless distinction is unknown.

The perfectly capable young Miss Michener likely rubbed elbows with pioneer Duster sailors of Riverton Yacht Club such as the legendary Merrills, Hunns, Lippincotts, Coes, Knights, and Shoemakers.

Town Historian Roger Prichard explains, "The Upside-Down Trophy is still awarded. In fact, the telling of the

embarrassing stories is the highlight of the Riverton Yacht Club banquet after the end of every season. I won it once."
